Sheriff's Report – Nate Gustafson and Mitch Slater
K-9 Unit

An update on K-9 Chase was given, Handler is currently in Nashville otherwise he would have brought Chase in to meet the Commissioners. Everything is working great.

Trespassing and ATVs

It was brought to the Sheriff's attention by Commissioner Abrahamson that with recent activity fences are getting cut, ATV's have been huge thing with lines and coolers (no empties in box of ATVS). Littering and having to continually picking up cans in ditch, yards, and streets. Commissioner Abrahamson is concerned that someone is going to get hurt either drinking and driving or land owners when they confront people about driving through their yards, fields. Deputy Mitch Slater stated he posted NDCC on Facebook, Land Owners need to post on property or there is nothing that can be done. Sheriff Gustafson and Deputy Slater stated they would talk to deputies on nice days/weekends. Adam Bryant made a statement about the amount of littering. He cleaned up a lot of cans by his mail box. It was discussed on posting something in the paper regarding the ATVS and trespassing. It was also discussed that possibly looking into fining ATV drivers for damage and littering. Sheriff Gustafson stated that it was hard to track down ATV Drivers, they don't want to cause one of them to drive off and get hurt.

Deputy Mitch Slater

Deputy Mitch Slater stated to the Commissioners that he has put in his resignation for Rolette County last day will be May 16th 2024. Commissioners expressed their thanks for all the Deputy Slater has contributed to Rolette County.

• Road Report – Mark Allery

Kelly Johnson spoke with Commissioners regarding Rolette Golf Course Road. Kelly Johnson believes that the gravel wasn't mixed correctly to stop it from running off the sides, and that the blades weren't doing a good enough job on these roads. Road Supervisor Mark Allery stated that currently with how wet the roads are, sending the blades out would do more damage than good.

Lake Schutte RD – Dust control was discussed as an option for the 11 miles. It is believed that it should be tested on the first 3 miles to make sure product can withstand the amount of traffic seen on road before spending \$55,000.00 on chemical that might not work.

Motion: Get estimates for the first 3 miles and an estimate for the entire 11 miles, send estimate via email and commissioners would be able to vote that way. Seconded by Mickelson

On roll call vote, all members voted, "AYE". Motion carried unanimously.

Plow truck is broken down, it was discussed parting it out and using what they could. Possibly scraping the rest.

St. John Shop fence looks horrible on St. John Main street, it was discussed to fix the fence and changing the color to white to make it more appealing and nicer. If costs stayed under \$1000.00 it would be completed and if price increased it would be brought before the board for approval.

Road Operator Brady Langan last day with Road Department for Rolette county will be Tuesday May 14 2024. Resignation letter sent to Auditor.

• Advertisement was discussed on hiring 2 full time road operators. It was approved to place in Turtle Mountain Star and Facebook.
